MINIMUM REQUIREMENTS

For the Summer Course there is a choice of participating in either a one week or a two-week course. Both will offer excellent training, with the two-week course providing more in-depth coaching. However, we do ask that applicants applying for the Summer Course are 11-16 years and have a minimum of RAD Grade 5/ RAD Intermediate Foundation or equivalent including pointe work. All courses will include classes in pointe for girls and coaching for boys.

Please note that 11year olds applying for the Course need to have turned 11 by 1 September 2018.

COURSE PAYMENT

Payment for the course can be made either via cheque, online, or by card over the phone. Cheques should be made payable to 'Central School of Ballet'. Please print the participant's name on the back of the cheque. Alternatively, you can pay online through our website <http://www.centralschoolofballet.co.uk/coursesonlinepayment.php>

You can also call the Widening Participation & Access Department during office hours (9.30am-5.00pm) and pay by credit/debit card over the telephone.

Please note that an additional administrative charge of £5 will be levied against any cheques that are returned by the bank.

In addition, please note that when paying online you will receive a notification of payment from WorldPay. This does not indicate that a place has been awarded on the course. Only a notification of acceptance from the Widening Participation and Access Department by email, upon receipt of your application form, confirms an allocated place on the course. If you have not received an email within 7 days of sending your application, then please contact the Widening Participation and Access department on 0207 837 6332.

REFUND POLICY

Please note that course fees, which are to be paid in full, in advance, include a non-refundable deposit. For the One Week Summer Course, the non-refundable deposit is £100.

- If you withdraw from the Summer Course **up to 7 days** before the start date, you will be refunded the fee minus the non-refundable deposit, and hence, Central School of Ballet will retain £100.
- If you withdraw from the Summer Course **within 7 days** of the course start date Central School of Ballet will retain 50% of the total course fee, which is £187.50.
- If you withdraw from the Summer Course **on the day** of the course start date or during the course, Central School of Ballet will retain the total course fee of £375.
- If you withdraw due to injury or sickness, refunds are made at the school's discretion, upon receipt of a medical note. However, it is noted that the school will retain the non-refundable deposit of £100.

Notification of withdrawal must be put in writing and sent to the Widening Participation & Access Department. Refunds will be issued based on the date of receipt of withdrawal notification. The date of receipt will be the date on which the email or letter is received by the Widening Participation & Access Department.

DRESS

Your usual ballet uniform of leotard, tights, ballet shoes (pointe shoes for the girls) will be required throughout the week. For other classes, no footwear is required but we suggest wearing convertible tights to easily change between classes. You may also wish to bring tracksuits and footwear for keeping warm between classes. You are welcome to bring Jazz and Character shoes, if scheduled, should you own them, but it is not essential.

TIMETABLE

Classes begin at 10am each day and usually end at 5pm. We recommend that you arrive 30-45 minutes before class starts on the first day of your course. Please also allow time to warm-up before each class.

We ask that students do not arrive earlier than 9am, and vacate the building by 6pm, each day.

Students will be assigned a group prior to the start of the course. You will be notified of your group when you receive the final timetable by email closer to the date of your selected course. Groups are chosen at our discretion and that decision is final. Groups will be reviewed by course tutors on the first day of the course. We will also provide any additional relevant information in advance of the course.

For all students enrolled on the one-week summer courses, there will be a work sharing on the final Saturday of each course. Students can invite up to 2 guests each. Precise timings for the Work Sharing will be released with the timetable.

BOYS ONLY CLASSES

Subject to a minimum number of boys applying for the course, we hope to offer boys only ballet classes.

ACCOMMODATION

Please note that our courses are non-residential, but we do provide recommendations of accommodation nearby. Accommodation must be arranged independently by applicants.

- 1) Demi plié in first position, arms in 2nd
- 2) Tendu devant efface (open position), arms in 2nd
- 3) First arabesque, en l'air (facing side)

Only girls with 2 years of pointe work experience

- 4) Fourth croisé on pointe, arms in 5th

Please note that girls must wear a leotard without a skirt and hair must be presented in a neat and tidy bun. Boys must wear leotard or fitted T-shirt and tights.

The photos can either be sent in a printed format with the application form via the post or uploaded as an email attachment if you are submitting the application via email.
